## Young people and ASB

# Antisocial Behaviour (ASB) Week

Neighbourhood Watch supported antisocial behaviour (ASB) week, which ran from 30 June - 6 July. It's led by [Resolve](#) and it is the UK's national ASB Awareness Week.

Antisocial behaviour is consistently one of their biggest concerns for NW members. But because ASB is a term that covers a range of behaviours, recognising what ASB is, can be difficult and reporting it can also be confusing. ## Summer blitz on ASB

Dr Fatima Eltinay and Abbie Coleman from Derbyshire NW joined Home Secretary Yvette Copper, for the launch of the summer safety blitz in Derby.



Over 500 towns will see increased police presence, stronger prevention and enforcement action by police and councils to support safer high streets this summer.

The plans include ramping up the use of targeted enforcement powers against troublemakers – including banning perpetrators from hotspots. Find out more on our [website](#).



## Knife surrender scheme

**The government is taking action to halve knife crime within a decade through its [Safer Streets Mission](#).**

To deliver that mission the government wants ban dangerous weapons, tighten the sale of knives online, have tougher sentences and more early intervention.

Deadly ninja swords will be banned from 1st August. In July, the government is running a surrender scheme across England and Wales to offer safe disposal of ninja swords at designated police stations. Find out more detail about surrendering ninja swords, including guidance and images, [here](#).

For those wishing to surrender other types of bladed weapons, not in police stations, there are community surrender bins and a mobile surrender van in communities across London, the West Midlands and Greater Manchester in partnership with knife crime charities, [Faz Amnesty](#) and [Words4Weapons](#).

# Tackling antisocial behaviour

# ERA

Antisocial behaviour can have a huge impact on those who experience it, and communities as a whole. But with a range of antisocial behaviours falling outside of the remit of the police, what can you do to help keep your community safe, peaceful and unified?

## Keep lines of communication open

When it comes to keeping your community cohesive, open channels of communication can be helpful – you'll have the chance to address any behaviours that bother you before things may escalate. Neighbourly disputes can have a big impact on all parties involved, so always try to keep conversations calm and collected when raising any issues.

## Recognise, Record and Report

Antisocial behaviour can take many forms, including excessive noise, littering, and household disputes. It's important to keep a record of any incidents to offer insight into how often these issues are occurring, and to provide details if you decide to take formal action to tackle the behaviour. Report antisocial behaviour early to prevent it from escalating, whether to your local authority, housing provider, or the police. # Summer safety tips

If you are lucky enough to be going away this summer, you may want to think about protecting your home.

Our advice is to think WIDEN - run through this quick checklist before you go away or leave your home. If you have all these covered, then you'll have the best possible protection against burglary. The acronym stands for:

- W - windows
- I - interior
- D - doors
- E - exterior
- N - Neighbours.

Prevention is always best. Don't let a crime ruin your well-earned break. We know it can be busy, and sometimes stressful, trying to get ready to go away, but it really is worth taking the time to keep your home secure.

## TRAVELLING

### TRAVEL INSURANCE

Travel insurance offers several key benefits that can provide peace of mind and financial protection. Ideally, your insurance should start from when you make your booking to cover any changes or cancellations prior to your date of travel.

### KEEP IN TOUCH

Share your travel itinerary with a trusted friend or family member. Regular contact can provide updates with any changes to your plans, as well as keeping up to date with news back home.

### RESEARCH

Local customs and laws vary widely depending on your destination. Researching and knowing what to expect can help you avoid potential issues. Familiarise yourself with local emergency numbers before travelling.

Travel safety is important whether you're staying local or travelling further afield. Being vigilant, prepared, and informed helps to ensure a safe and enjoyable trip.

### TRANSPORT

Choose licensed taxis or use an official app for local information and help with booking public transport. If renting a vehicle, ensure it's from a reputable company. CDW insurance typically covers any damage to your rental vehicle while in your possession.

### DOCUMENTS

Make copies of your passport, driving licence, travel insurance, and other important documents. Keep them separate from the originals and consider storing digital copies or screenshots.

### PERSONAL BELONGINGS

Don't leave your belongings unattended. Secure your luggage using TSA-approved locks. Avoid carrying large amounts of cash. A money belt or hidden pouch helps to keep your valuables safe. Be mindful of your surroundings when using your phone.

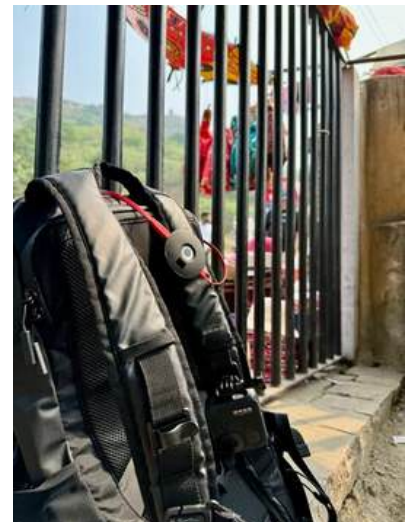

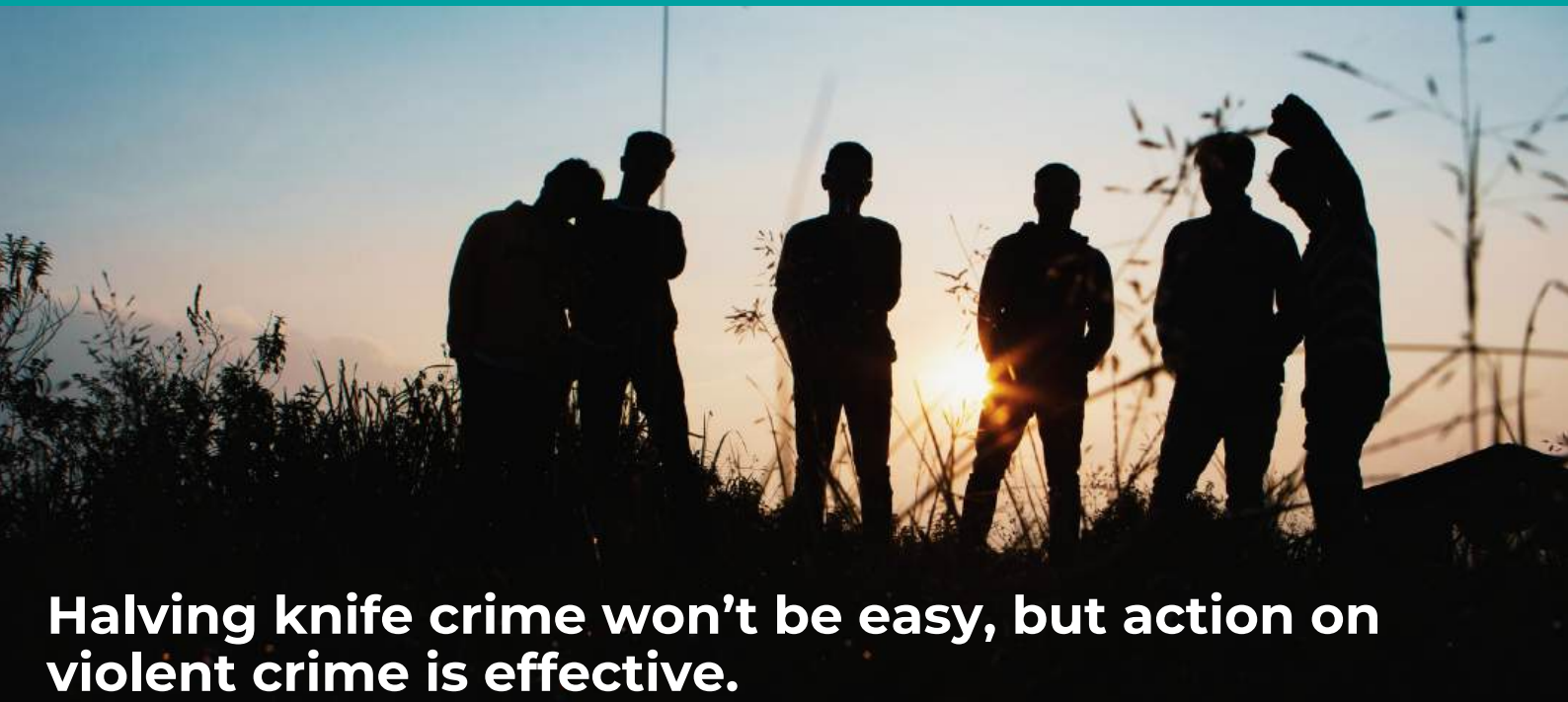

## Halving knife crime won't be easy, but action on violent crime is effective.

When we read about fatal stabbings of young people making headlines across the country, it is both heart breaking and frightening.

Every child's life lost is devastating, not only to their families but also to their communities. It is very understandable that you might feel overwhelmed by the scale of the problem,
